Based on the signed MoU between Wiha and TUEBA on December 2019, the Memorandum of Agreement (hereafter referred to as "the Agreement") is to express the mutual interests to promote a close cooperation between the university and the private company Wiha, both in Vietnam and Germany. A scholarship program among one or several German universities, TUEBA, WIHA GERMANY, WIHA VIETNAM is established on the basis of equality and reciprocity and to promote relations and mutual understanding among the Parties.

Article 1: Scholarship program for TUEBA students to study and do internship in Germany

- TUEBA will send qualified students to study at one Germany university for



one semester and after that the students will do intership in Wiha Werkzeuge GMBH Germany for six (06) months. Total time to study and do intership in Germany is one year.

- WIHA will subsidize for 1 student per year with a scholarship of €5.000.
- TUEBA will recommend potential candidates for those programs and it is mandatory that they could speak excellent English.
- WIHA will have a short video – interview with potential candidates prior to agreeing to a scholarship case – by - case.

Article 2: Scholarship program for students to study at TUEBA

- Candidates are studying Bachelor's degree in TUEBA at least 3 semesters or they are studying Master's degree in TUEBA.

- WIHA VIETNAM will sponsor a scholarship for those selected students for the rest of their university career – maximum until finalization of their respective degrees. The scholarship is €1.000 per year for each student. Maximum of 5 students are supported each year.

- Those selected students have to write their Bachelor's and Master's thesis based on predefined project topics from WIHA VIETNAM and/or spend their intership at the company. WIHA VIETNAM will support with additional pocket money during their stay at the company.

-TUEBA will recommend potential candidates for those programs and it is mandatory that they speak excellent English.

- WIHA will have a short-video or face-to-face interview with potential candidates prior to agreeing to a scholarship case – by - case.

Article 3: Validity



- This Agreement is not intended to be legally binding. Nothing, therefore, shall diminish the full autonomy of either Party, nor shall any constraints be imposed by either Party upon the other Party in carrying out this Agreement. Except as noted otherwise, compensation and private liability in the event of default is always excluded.

- This Agreement shall come into effect since 01/01/ 2021 and shall be valid for a period of three (03) years.

- This Agreement may be renewed, revised or modified after discussion by representatives of both Parties.

This Agreement will be made in six (6) original copies, providing two (02) original copies for each Party.
